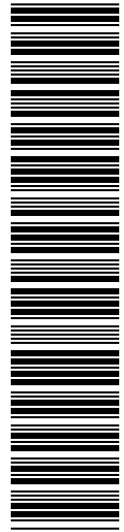

**Health & safety:** Keeping you safe is our top priority



### Vaccination

All guests 12 and older must present proof of full COVID-19 vaccination with the final dose given at least 14 days before sailing (not including your sail day). Vaccine boosters are encouraged. Kids 5-11 who present proof of full vaccination may follow the protocols for vaccinated guests. Royal Caribbean accepts vaccines that are fully approved or authorized for emergency use by the U.S. FDA or the World Health Organization, with the exception of CanSino.

### Vaccine FAQ

#### U.S. entry requirements

Testing is not required to return to the U.S. For any other country return home, please check your country's re-entry requirements for specific testing information.

### Learn more

#### Pre-cruise testing

Vaccinated guests must show a negative PCR or antigen test result taken no more than 2 days before boarding day.

Unvaccinated kids ages 2-11 must show a negative PCR test result taken no more than 3 days before (not including) boarding day.

Tests must be supervised with the result provided on a certificate which includes the guest's name and date of birth. Supervised telehealth tests are only accepted for vaccinated guests. Arrangements and costs for pre-cruise testing are the guest's responsibility.

### Pre-cruise testing options

#### Sail day testing





Unvaccinated kids 2-11 will take a complimentary antigen test for COVID-19 during check-in. Registration details will be emailed in advance.



### Travel documents

-Passport book or card valid for at least six months after your cruise. If you do not have a passport, you may present a U.S. state-certified birth certificate. Guests 16 and older that present a birth certificate must also provide a driver's license or government-issued photo ID.  
-COVID-19 vaccination record card for vaccinated guests  
-Negative test result for COVID-19 (printed or official result on your phone)

### Face masks

Masks are optional for vaccinated guests and recommended for unvaccinated children while onboard. In our terminals, masks are optional unless required by local regulation. Some destinations we visit may require masks. Guests younger than 2 years old don't need to wear a mask.



### Denial of boarding

Failure to meet or comply with any of our health and safety protocols may result in denial of boarding.

### Refusal to Transport Policy



### Port stops

All guests must follow the applicable health protocols for the ports we visit.

All parties may book a shore excursion or visit most ports freely — with the exception of those listed below, which have special requirements.

St. Lucia

At St. Lucia, all guests may depart the ship and visit the enclosed port area on their own. If they wish to visit further into the island, they must have booked a Royal Caribbean International shore excursion, or participate in a government approved tour. The government approved tours are unaffiliated with Royal Caribbean.

Barbados  
St. Vincent

At the above ports, all guests must purchase a tour through royal Caribbean if they wish to go ashore, regardless of vaccination status.

Antigua

In Antigua, parties with all vaccinated guests may visit the port freely. Parties that include unvaccinated guests must purchase a tour through Royal Caribbean.



### Departure testing

Unvaccinated kids 2-11 will take a complimentary antigen test onboard before the cruise ends for any sailing 5 nights and longer, or any cruise that stops in Bermuda regardless of length. Registration details will be provided onboard.



### Protocols subject to change

All health and safety protocols are subject to change. We are committed to communicating any updates that may occur prior to your cruise. Future protocols may include booster requirements, lowered vaccination ages, and/or changes to testing. While not currently required, vaccine boosters are recommended.

### Certificate of Recovery

A Certificate of Recovery and a positive PCR test taken between 11-90 days prior to our sail date can be provided in place of a negative pre-cruise test to sail with us. Please note: we will not accept a Certificate of Recovery in the place of a vaccination record. Some ports of call do not accept Certificates of Recovery for the purposes of debarking and enjoying the destination.

## Day before your cruise: Answer your health questions in the app

Save time and vacation sooner. Sign in to the app, we'll send a reminder notification to complete the health questions.

Can't access the app? Answer your health questions at the terminal.

**Boarding day: Honor your arrival time at the terminal**

Everyone will receive a wellness check before being cleared to board. Guests who arrive outside of their scheduled arrival time will delay their boarding. Be sure to have your travel documents handy.

**Onboard: Complete your safety briefing**

Connect to the ship's free Wi-Fi (no internet package required, in-app charges), tap Safety on the app's home screen to launch the safety briefing, then stop by your assembly station before the ship sails. No app? Go to your assembly station and a crew member will assist you.
