### COVID-19 VACCINATION, BOOSTER & TESTING REQUIREMENTS

Due to the itinerary of this voyage, guests ages 18 and above must be fully vaccinated for COVID-19 and, if eligible, have received a COVID-19 booster. Eligibility is determined by the U.S. Centers for Disease Control and Prevention (CDC) guidelines at [https://bit.ly/cdc\\_booster](https://bit.ly/cdc_booster). Only one booster dose is needed to be considered fully vaccinated, and boosters may be received any time up to embarkation.

Guests ages 5 and above must produce a negative viral COVID-19 test (medically observed PCR or antigen test) taken within three days before cruise embarkation.
