Twin Beds Do Not Convert to Queen

Passports are required for international travel and for all air departures to or from the United States. Passports must be valid for six months after the completion of travel and contain enough blank pages for entry and exit endorsements and any required visas. Names on passports and the booking must match. If minors are traveling with only one adult 21 years of age or older, Princess requires that all passengers travelling in the party must present a valid passport at embarkation.
