



Health Acknowledgment

Prepare to Cruise

It's the responsibility of each guest to acquire necessary travel documents for their entire journey, including consecutive cruises. Guests who fail to present required documents on boarding day may be denied boarding and will not be eligible for a refund.

Valid travel documents such as passports, visas, inoculation certificates, and family legal documents are required for boarding and re-entry in the United States and other countries. Guests should check with their government authority or travel agent to understand documents needed for each destination, including their port of embarkation.

Guest should remain up to date on travel document needs, as government requirements are subject to change at any time.

DOCUMENTATION AND IMMIGRATION REQUIREMENTS

- Regardless of destination, we encourage guests to bring a valid passport that expires no fewer than six months after their cruise.
 - o U.S. Open Loop Itineraries (sailings that begin in a U.S. port, travel within the Western Hemisphere, and end at a different U.S. port): All guests, including children and U.S. citizens, a required present a valid passport when sailing on.
 - <u>U.S. Closed Loop Itineraries</u> (sailings that begin and end in the same U.S. port without leaving the western hemisphere): All guests, including children, must provide either a passport or other government issued documentation, such as a birth certificate and laminated government issued picture ID with photo, name, and date of birth. Baptismal papers, hospital certificates of birth, voter registration cards or Social Security cards are not accepted.
- Some ports of call require a tourist visa. Visit the visa provider of your choice or the website of the Embassy (Consular Services) for each country on your itinerary to learn specific visa requirements, information, forms, and fees.
- The spelling of the guest(s) name on their cruise booking must match their proof of identification.
- The name of the parent(s) and the child traveling with them must be linked through legal documentation. Should the last names of the parent and minor child differ, the parent is required to present the child's valid passport and visa (if required) and the child's birth certificate (original, a notarized copy or a certified copy).

Spending Onboard

- When deciding which credit/debit card to associate with your SeaPass onboard spending account, keep in mind that temporary holds or authorizations may be placed on it. While not actual charges, holds will reduce available funds. Most are released within 3 5 days after your cruise, but some may take up to 30 days. Contact your card issuer to remove any holds after your cruise. If the form of payment on your onboard account was changed, prior holds will remain on the original card until final charges are submitted at the end of the cruise.
